- 4. Report by West Devon Borough Councillor:

West Devon is concerned about the lack of social and affordable homes in the borough, they want to encourage two bed houses being available at affordable prices. Borough Councillor Ratcliffe has made some contacts with small plots of land which could be built upon. He is looking for small parcels of farmland to build affordable housing for the youngsters to allow them to stay in the areas they live and work in. However social housing groups who own and rent homes are selling them off and are buying affordable housing as new builds to then rent at a higher price. It was suggested that some youngsters want to move out of their rural areas to have better access to shops, buses etc.

- 6. Clerks Report and Correspondence received:
  - 6.1 WDBC Support Directory: this has contact details for anyone who needs financial etc. help during these times. The clerk asked Councillor Allin if she would put the notice on the notice board.
  - 6.2 Civility & Respect project: the clerk has read this and some of the information needs to be put into the Code of Conduct, which does need up dating. The council agreed.
  - 6.3 DALC ref: meetings: that all meeting must now be held physical, face to face. They also state that Council Meetings are regarded as work for councillors and clerk alike.
  - 6.4 Devon & Somerset Fire & Rescue Services: after a survey about their services, they have a new management plan online and are inviting further comments.

7.1 The Old Quarry 337/21/FUL: a letter was sent to support this application and as yet no response has been made by WDBC planners. Councillor Ratcliffe had some further information: the planning officer is using the West Devon Local Plan to refuse this application. Although it depends on how you interpret it. She does have someone helping her in her quest, and has written to the planners. The council feel to refuse this is unreasonable as it seems it is all about buses and shops, which is a contentious way of looking at it but the planners are standing their ground. Possibly the way forward would be to withdraw the application, review and reapply. No one sees any reason why it should not be allowed and totally support Mrs Sims. She is considering her options.
