- 1. To receive apologies for absence and consider if the reason for the absence should be formally approved by the council: none received
- 2. To receive any Declarations of Interest from members:

- 3. To receive the Minutes of the Previous Meeting held on Wednesday January 5th 2022 Copies of which have been previously circulated to members and are to be agreed and signed by the Chairman as a true record of the previous meeting held on January 5th 2022. These were agreed and signed.
- 4. Report by West Devon Borough Councillor: not in attendance
- 5. Past subject matters for further discussion:
 - 5.1 [6.5] Queens Jubilee: The clerk provided some examples of various souvenirs that the council could purchase for the children of the parish to celebrate the jubilee. Counting the children, it was decided that 21 were under the age of 16years. After much discussion the council decided to purchase 25 mugs of one design and 10 mugs of another design from one company. The clerk will order these.
 - 5.2 [6.6] Highways: There are a few old road signs laying around in the village and it was decided to collect them up and put them by the grit bin. Once this is done the clerk can contact Highways to remove them.
- 6. Clerks Report and Correspondence received:
 - 6.1 Boundary Commission: new proposals for splitting up County Councils: after discussion the clerk placed this into the Councillors folder. Councillors can send in their comments via the web site.
 - 6.2 Winter Report Budget from James McInnes: this was placed into the folder.
 - 6.3 News Release: tackling housing crisis: this was placed into the Councillors folder.
 - 6.4 Devon CPRE: they are asking if the council wish to join the scheme for quite a high fee. The council have declined
 - 6.5 The Rural Services Network: this is highlighting the inequalities of health care in rural areas. It recommends that services are suited to the specific needs of the rural areas.
 - 6.6 "20s Plenty for Us": there is a nationwide campaign promoting a speed of 20mph to be normal on residential streets and in town and village centres.
 - 6.7 Email from parishioner ref: trees: this is with regard to the trees overshadowing the car park. The nearest and tallest one is a large fir tree. Several people have reported that the trees are leaning across the car park and are concerned about the stability of them. The
